Rules/Terms

The selection of winners will take place on the 10th of each following month and the Grand Prized drawing will be held by the 06/25/12. Winners will be notified by e-mail or telephone by 06/30/12 to the e-mail address or telephone number provided by Entrant to the Sponsor upon registration of the Contest. Upon notifying the winner of his or her prize, the winner will be requested to submit his or her preferred mailing address. The Grand Prize winner must be currently employed by a current Ziker Uniform customer.
